General information about Kharsang Oil Field

The Government of India entered into Production Sharing Contract (PSC) with a consortium of Oil India Ltd., Geopetrol International Inc., JEKPL Pvt. Ltd. (Formerly known as Jubilant Energy (Kharsang) Pvt. Ltd.) & GeoEnpro Petroleum Ltd. (together known as Contractor Parties to the PSC) for development of Kharsang Oil Field in Arunachal Pradesh, India.

GeoEnpro Petroleum Ltd. (GEPL or Company) is the Operator of the Kharsang Oil Field. Company's operations base is at Kharsang Field, Changlang District, Arunachal Pradesh and its head office located at Noida, Uttar Pradesh. The Kharsang Oil Field is spread over approximately 10 square kilometer area, with access roads and sand graveled well locations.
